
**MOTION FOR LEAVE TO FILE CM/ECF**

The Plaintiff, Curtis J. Neeley Jr., MFA, enters this motion personally after printing the Motion for Leave to File CM/ECF on paper and driving the Motion for Leave to File CM/ECF to the District Court office in Fayetteville. This motion seeks leave to file supplemental pleadings CM/ECF and thereby reduce the costs of this litigation for the Plaintiff. These costs will become costs sought from each Defendant after this Action resolves in the Plaintiff's favor. Every pleading from this point forward is "supplemental" and supports Docket #5 even when opposing subsequent Motions to Dismiss or opposing Motions Seeking Summary Judgment. The Plaintiff's Motion for Summary Judgment will be supplemental to the "Conclusion" section of the Complaint ¶15 on page 16 of the complaint.

Plaintiff requests leave to file CM/ECF only in Neeley Jr v FCC, et al. Plaintiff realizes Leave to File CM/ECF does not excuse violations of any of the Rules of CP or Local Rules and Leave to File should be granted provisionally and be made subject to being withdrawn by Clerks of the Court if determined prudent and not further burden the busy District Court. The Eighth Circuit Court of Appeals already permits *pro se* parties to file CM/ECF and this fact supports granting this Plaintiff Leave to File CM/ECF in the interests of justice. A Supporting Brief is not required for Motions for Leave to File Supplementary by CM/ECF per Local Rules 7.2(d)(2).


