BRIEF SUPPORTING MOTION FOR DISMISSAL OF DOCKET #19 (MOTION to file sealed exhibits)

- Plaintiff filed the Motion to seal or docket #19 because of Plaintiff's honest mistake and not realizing the PACER system requires no access by anonymous personnel already. This motion however, remains prudent since the CM/ECF system does not grant *pro se* parties the same Due Process given represented parties due to the District Court Clerk's scans of filings and exhibits. The quality of these scans make filings and exhibits low resolution black and white images left to approximate filings of *pro se* Plaintiffs and also makes these files not text searchable and therefore makes these non-compliant with Eighth Circuit Appellate Court Rules.
- 2. The fact that the District Court required these exhibits to be viewed in camera ensured that this District Court became very familiar with these indecent and obscene exhibits. The Plaintiff previous motion to become an CM/ECF party that was denied requires *pro se* parties who are not attorneys to otherwise simply hope the District Court might view colored and indecent exhibits. These scan approximations are wholly insufficient and unfair based on this Plaintiff's unique past experience with this District Court.

- 3. The prior Motion to Seal was, however, an honest mistake due to the Plaintiff's desire not to further spread the access to these indecent exhibits to minors. The Plaintiff's mother was suffering a great deal when this Motion was made and died December 3, 2012. This emotional strain perhaps caused this Plaintiff's mistake.
- 4. This Plaintiff will file oppositions to each motion concurrently with exhibits that are not sealed because District Court's PACER scans will mutilate these exhibits and partially obscure the indecent photographs. CM/ECF filings are not made available to unidentified minors already as was the purpose sought mistakenly with the Motion to Seal.
- 5. The Plaintiff apologizes for exposing this District Court's personnel to current obscene and indecent exhibits.
