Therefore, you are hereby notified that you must either pay the fees in full or renew your in forma pauperis motion in this court by April 8, 2013. If you fail to take one of these two steps, the court will issue an order directing you to show cause why the appeal should not be dismissed.

On June 1, 2007, the Eighth Circuit implemented the appellate version of CM/ECF. Electronic filing is now mandatory for attorneys and voluntary for pro se litigants proceeding without an attorney.
