Rural Arkansas Churches

"Forgotten but not yet GONE."

Hearing the modern, progressive, and unique United States' concept of "*Separation of Church and State*", there are millions of citizens today who are ready to put God back into the State in a real and "limited" way. 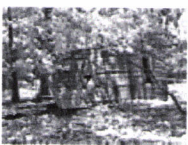

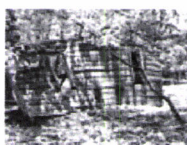
