# Supplemental Brief ordered by Honorable Erin L Setser in the December 6<sup>th</sup> hearing

Plaintiff was ordered to report about further attempts to remove nude images from the Defendant Google Inc image search without requiring a court order. Defendant Google Inc stated that the Wikipedia licensure was authorization to show nude art to children and Muslims and Michael Henry Page Esq was ordered to print the CC-BY-SA 3 license for the Court. Michael Henry Page Esq also called the Wikipedia article a "BLOG" posting in error and claimed it was under the complete control of the Plaintiff. The Plaintiff was one of a multitude of editors who could edit articles but Michael Henry Page Esq mislead the Court regarding the level of control the Plaintiff has over articles. This misleading by Michael Henry Page Esq was similar to Jennifer Haltom Doan Esq misleading the court reporting that text that could be a link was as much a rational for displaying Michael Peven's erect penis due to 'Curtis Neeley' searches, as an actual link would have been.

Michael Henry Page Esq and Jennifer Haltom Doan Esq misled the court due to being insufficiently schooled in wire communications and without malice. The Plaintiff invested a great deal of work and proved for Jennifer Haltom Doan Esq that a link is not the same as text and added and then removed the link for demonstrative purposes.

### Wikipedia "BLOG" revision attempts

The Plaintiff was able to revise his user profile page at Wikipedia and deleted the nude photographs done by the Plaintiff that were used in articles that are not like BLOGs in the least. The deletions were reverted by OTHER users and the Plaintiff was banned from editing Wikipedia and could not alter anything while this litigation continues. The Plaintiff is unable to add or remove anything but agrees with Wikipedia Foundation Counsel that Google Inc should not be allowed to require users to opt-out of being thumbnailed but should be ordered to not thumbnail unless specifically invited to do so by the artists using the robot exclusion protocol as a default do-not-index.

### FineArtAmerica.com "REP" and GOOG disobeying

The Plaintiff examined the image search for "Curtis Neeley" and found a great number of nude photographs that resulted from <FineArtAmerica.com>. The Plaintiff proceeded to contact <FineArtAmerica.com> and requested that the Plaintiff's nude photographs be excluded from the googlebot-images search spider. FineArtAmerica.com has already modified the robot.txt file as requested. Upon closer examination it appears that many of the nude images were already in directories that were not supposed to be searched. It is of absolutely no value to establish "REP" or rules created by the Defendant when the Defendant does not follow the rules it makes. The Plaintiff was no longer allowed to edit Wikipedia for several days and <FineArtAmerica.com> has now altered their robots.txt file and the Wikipedia Foundation has altered attribution to the CN Foundation instead of "Curtis Neeley". The efforts of the Plaintiff could have been seen in the prior exhibits except contrast was increased and relevant text was not legible so they are included as Ex. Wiki D and a week worth of ceasing free speech is documented in Exhibit A and dialogs with fineartamerica.com is included in Exhibit B and the <di>dictionary.com> definition of integrity is included as Exhibit C in order for Michael Henry Page Esq to learn it and instruct Defendant Google Inc in the use of the word in US Title 17 § 106A.

### Google Inc BLOG attributions

Google Inc owns <br/>
slogspot.com> and should not have confused Wikepedia.com with a BLOG. <nimril.blogspot.com/> was a BLOG entry that caused a nude to appear attributed to the Plaintiff correctly but was not posted by the Plaintiff. The Plaintiff contacted the person who had posted the moon poet nude image and attributed it correctly to the Plaintiff. The BLOG is in Spanish but the Plaintiff posted a comment and requested it be attributed to the CN Foundation if used. The BLOG manager removed the use of the nude by the Plaintiff and this has already resulted in it no longer returning in the images.google.com search. Google Inc is claiming that any BLOG post that correctly attributes a nude image to the Plaintiff gives Google Inc the right to display these nudes to children in spite of the intent of US Title 47 \ 230 and while using US Title 47 § 230 and alleging it protects Google Inc from liability as an ISP despite the fact that this is exactly the opposite intention of the statute. Google Inc is not an ISP and makes a great deal of money selling advertisements to actual ISPs attempting to sell Internet connectivity. Google Inc relies on older judges who are apparently easily convinced that Google Inc is an Internet Service Provider protected from liability while providing pornography to minors and NOT providing connectivity.

Google Inc was sure to point out that other old judges have ruled Google Inc was an Internet Service Provider and again claimed to be an ISP in a bare deception to Honorable Erin L Setser during the hearing. This use of the term ISP is deceptive and Google Inc is not an ISP regardless of how many elderly judges they can convince that they are. Google Inc will not deceive a JURY or even another judge in the next decade or so after judges begin to have more familiarity with wire communications as defined in US Title 47 § 153 ¶ (52) and called the Internet elsewhere to bypass regulations. US Title 47 § 230 is titled § 230. "Protection for private blocking and screening of offensive material".

It was interesting how Google Inc counsel attempted to refer to their "pet" statute as not written to protect screening but "ANOTHER" section being titled this way. The reference was to \$230 (c) titled: Protection for "Good Samaritan" blocking and screening of offensive material so what Google Inc Counsel alleged had enough truth for a lawyer to say "ANOTHER" section was titled regarding blocking offensive material. US Title 47 § 230 is entirely titled "Protection for private blocking and screening of offensive material". The Statute is entirely titled to reflect the opposite intent to what Google Inc uses the Statute to avoid liability for being a pornography content provider. Google Inc traffics in pornography as their primary business and yet alleges that they only organize other people's pornography or other people's data.

Whereas Curtis J Neeley Jr has done everything humanly possible to help Google Inc to stop showing nudes in safe images searches for "Curtis Neeley" including altering personal speech and artistic expressions and asking other sites to follow the Google Inc Robot Exclusion Protocol (REP) even when Google Inc does not currently follow it; Curtis J Neeley Jr prays Honorable Erin L Setser now order Google Inc to not return nudes in searches for "Curtis Neeley" regardless of where on the Internet Google Inc locates nude images done by the Plaintiff. The Plaintiff also prays that the Robot Exclusion Protocol (REP) become an opt-in instead of an opt-out so that no directory is searchable by an image search unless it is specifically listed as granting the right to search engines to make thumbnails. The Plaintiff states that there is usually an assumption of privacy being recognized that has been eliminated now by Google Inc. Putting material on a website should not grant Google Inc or other parties the right to sell access to it in violation of US Title 17 § 106A. Thumbnails as large as the originals are nothing but copies and not subject to the fair-use exceptions in US Title 17 that Google Inc exists exclusively because of.





Although Curtis has a severe disability, he is determined to continue creating meaningful visual art. The Curtis Neeley Foundation will be created to preserve and promote his artistic photographic legacy.
